

# Introduction

August 5, 2019 marked a historic day for Indian polity when the current government announced the abrogation of Article 370 of the Indian Constitution. Article 370, which accorded special status to the state of Jammu and Kashmir, right from its inception with the Instrument of Accession executed by Raja Hari Singh, has remained a controversial piece of legislation and has been the source of much political and academic comments. Similarly, Article 35A of the Constitution has always acquired a prominent focus in politico-legal discourse with there being repeated calls, time and again for its repeal. Now that the provision has been revoked, the discussions as to the ramifications of the move, have begun with renewed fervor and the entire country as also the international community has been closely monitoring the subsequent developments. While the proponents of the move are hailing it to be a move from 'the formal accession of the state made on 26th October 1947 to its total integration within the country, there are serious apprehensions being voiced by other quarters about there being gross human rights violations in the valley and the 'sense of betraval of the idea of self-autonomy promised to the people'. What the move entails for India's position at the international fora is another aspect that merits discussion. This Conference provides an opportunity to the participants to explore the various dimensions related to the issue and provide their respective perspectives and viewpoints so as to enable a holistic and in depth understanding of the same.
