Justice V.R. Krishna Iyer Memorial Lecture series

"General Elections, History and Electoral Reforms" - Lecture by Sh. K.C. Mittal (Chairman, Bar Council of Delhi)

On March 19th, 2019 the Seminar Committee of the DME organized lecture on the topic "General Elections, History and Electoral Reforms" by Sh. K.C. Mittal (Chairman, Bar Council of Delhi) at the Nelson Mandela Auditorium. Prof. P.N. Parashar introduced our honorable guest and shared about his vast experience with the Election Commission of India. Mr. K.C Mittal enlightened the audience comprising of faculty and students about the importance of elections in our country. He also shared that how Justice Krishna Iyer who was once arrested, rose to be the Supreme Court Judge. It was an apt opportunity to have a discussion on electoral process considering the forth coming elections.

Sh. Mittal shared with students his vast experience of working with Election Commission of India where he witnesses the growth of election and refinement of electoral politics. He shared that the institution performs its functions with utmost dedication and with a sense of responsibility to uphold the faith that people of India have bestowed on it. Sh. Mittal also discussed with the students his concerns over the modern electoral



practices, such as criminalization of politics. He opined that the use of muscle power in politics is failing democracy. Sh. Mittal urged the students to become vigilant citizens and to save elections and thereby save democracy. He said that the voter has to act with greater sense of responsibility in electing their leaders. He motivated the students to ensure that the right persons are elected so that the Constitution and spirit of India is upheld.

The lecture was followed by active participation of students in the question-answer round. It was motivating for the seminar committee to observe that the students were much more enlightened about the election process and informed about their responsibility as a voter of the world's largest democracy.

3rd National Moot Court Competition & 1st National Client Counselling Competition

The third edition of National Moot Court and the first oneday National Client Counselling Competitions were organized by Delhi Metropolitan Education (DME) on the 5th, 6th and 7th of April, 2019. These competitions provides platform to sharpen advocacy skills and public speaking skills for the lawyers of tomorrow. The first day saw the gracious presence of Advocate Naveen Kumar Jaggi as the Chief Guest of the Inaugural function, Justice Bhanwar Singh (Director General, DME), Prof. Ravi Kant Swami (Director, DME), Prof. N.K. Bahl (Dean, School of Law), and Prof. Bhavish Gupta (Head, School of Law) as the dignitaries at the opening.

The event commenced with lighting of the lamp and seeking blessings of Goddess Saraswati at the Nelson Mandela Auditorium. It was followed by the proceedings of the Client Counselling session for the finalists; Team 117, MNLU, Nagpur and Team 101, North Cap University from among other participants, namely North Cap University, Gurugram, VIPS, Delhi, Amity Law School Noida, Symbiosis Law School, Pune, Bennett University, MNLU Nagpur, USLLS, Amity Law School, Delhi etc. Team 117 was the first one to uphold the session. The counselling concluded with the Award Distribution ceremony. The North Cap University bagged the first prize and MNLU, Nagpur was the runner-up at the competition. The high point of the event was honoring Justice Bhanwar Singh, the Director General, with a Lifetime Achievement Award by the Chief Guest for his contribution to the law and an astounding career. "This award is being presented to you not because of your very warm and gracious hospitality but knowing well that how you are coming from the backyard of Delhi outskirts, how you arose from the ashes like a phoenix.", Advocate Jaggi remarked. Justice Singh shared a heartfelt vote of thanks for this precious and unforgettable moment. He appreciated the hard work done by the Moot Court Committee to make this event a great success and creating a benchmark for such platforms in Delhi NCR.

The first day of the National Moot Court Competition concluded with the declaration of the winner of the 1st Client Counselling Competition and the drawing of lots for National Moot Court. The second day saw the campus abuzz

with participants from across the country. After a meticulous regulation of Court room sessions and tactful mooting done by a total of forty-five teams from various states of India, the much awaited day of the Finale begun with the Semi-final Round from 11 am. Only four teams qualified to this level; Team 107, Symbiosis, Pune; Team 111, University School of Law and Legal Studies, GGSIPU; Team 116, Chandigarh University, Mohali and Team 136, Law Centre-1, DU. Followed by an intense Semi-final Round, Team 107 and Team 111 were leading the scoreboard and made it to the Final Round.

The Final Round commenced in the Nelson Mandela Auditorium of the institution, graced by the presence of Justice Alok Mathur as the Chief Guest, Justice V. Eswaraiah as the Guest of Honour and Director General (DME) Justice Bhanwar Singh. The final round came to an end after two hours of constant unswerving deliberations. The event's splendour attained the highest level with the arrival of the Guest of Honour, Advocate Monica Arora. She addressed the audience with great enthusiasm and spoke about the right to freedom of speech in India.

The event proceeded towards the announcement of final results: the Best Researcher Award-Kadam Nikitha, Army Institute of Law, Mohali; the Best Speaker Award- the speakers of Muskan Gupta and Teesta Mishra, University School of Law and Legal Studies, GGSIPU; the Best Memorial Award-Sikkim Government Law College. Symbiosis, Pune were declared the winner of the third National Moot Court Competition at Delhi Metropolitan Education.

National Conference Mergers & Acquisitions: Legal & Managerial Review

Felicitation of the Chief Guest Shri Dhanendra Kumar

On 27th April, 2019, DME hosted a National Conference on Merger and Acquisitions: Legal and Managerial View. It was conducted in collaboration with the DME Management School. Shri Dhanendra Kumar, Former Chairman of Competition Commission of India grace the occasion as the Chief Guest, while the keynote address was delivered by Shri P.K. Singh, Secretary, Competition Commission of India. Mr. Singh elaborated on the procedure and remedies available with regards to anti competition practices that lurk beneath the garb of mergers and acquisition. He stressed that while Mergers and Acquisitions are undeniably a practice to control the financial capabilities of firms and industries, it is also a festering ground of cartelization, thus leading to monopoly of trade. This, Mr. Singh stated, is extremely harmful to the consumers who have to suffer steep price rise and supply control. He thus, underlined the importance of Competition Commission of India in keeping anti competition practices at bay.

The event also marked launch of the Conference publication as a part of a special edition of the UGC recognized Journal, "International Journal of Advance and Innovative Research".

There were three plenary sessions conducted simultaneously to cover the nitty-gritty of the theme. Various interesting and novel ideas were deliberated and discussed during the sessions. For instance, Ms. Sanober Khan from Delhi Technical Campus presented a wonderful critique of the practices of mergers and acquisitions looking at it from the lens of cultural issues. She averred that companies and large conglomerates in their zeal to merge or acquire sometimes fail to assess the social and cultural capital of the employees involved with the merge or acquired company, leading to a weakened giant and resultantly, a weakened financial policy.

The most unique characteristic of this Conference was that there was a dialogue established between the two disciplines of Law and management over a common point of convergence. The interdisciplinary nature of Law is something which is now well established within the intelligentsia. DME succeeded in bringing scholars from both fields to establish a discourse with each other and understand the other world view and perspective.
